WARWICK ANDERSON is Associate Professor of the History and Philosophy of Science, and Director of the Centre for the Study of Health and Society at the University of Melbourne. He has published widely on the history of American public health and on race and colonialism in Southeast Asia. His current project is a history of racial and environmental thought in Australia.

LINDA BRYDER teaches History of Medicine at the University of Auckland and is a member of the Advisory Editorial Board of *Health & History*. She is author of *Below the Magic Mountain* (Oxford 1988) and editor of *A Healthy Country* (Wellington 1991).

JOHN C. BURNHAM is Professor of History and (by courtesy) Professor of Psychiatry at the Ohio State University in the USA. His most recent book is *How the Idea of Profession Changed the Writing of Medical History*. He has completed a history of childhood lead-poisoning and is currently working on the deinstitutionalisation of mental patients in the 1950s.

A graduate in Medicine from the University of Sydney, he first worked in general practice before becoming a consultant physician with a commitment to medical education. He is also an amateur medical historian, book collector and enthusiastic *feuilletonist*.

CECILY HUNTER is completing a PhD on the history of geriatrics and gerontology in Victoria. She organises the History of Medicine Working Group at the Centre for the Study of Health and Society, University of Melbourne.

JUDITH RAFTERY has a PhD in history from Flinders Univer-

sity. She is currently a Senior Lecturer in the Department of Public Health at Adelaide University, where she convenes the Master of Public Health program, and teaches public health history and policy. She has a particular interest in indigenous health policy, and is working on a history of the health of Aboriginal South Australians.

BELINDA ROBSON is currently completing her PhD on the career of Eric Cunningham Dax in the History Department at the University of Melbourne. Prior to this, she completed a Masters in Applied Social Research and an Honours degree in History, in which she looked at female patients in the Yarra Bend Asylum in the early 1900s. She has also worked on a number of community-based research and policy projects in the areas of mental health, sexual assault and youth homelessness. She is currently teaching at the University of Melbourne's Australian Centre.

LUCY TAKSA is a Senior Lecturer with the School of Industrial Relations and Organisational Behaviour at the University of New South Wales. She co-authored *Australian Readers Remember* with Martyn Lyons, and has published in Australian and international refereed journals on scientific management, labour culture in Australia and Canada, community, and oral history. She is currently working on two ARC-funded projects focused on the NSW Eveleigh Railway Workshops. She is the Federal Secretary of the Australian Society for the Study of Labour History and an Executive Member of the History Council of NSW.

DI TIBBITS is an Associate of the Centre for the Study of Health and Society at the University of Melbourne and is currently President of the Medical History Society of Victoria. She has a particular interest in sexually transmitted diseases and women's health, her doctoral theses being on aspects of venereal disease from 1860 to 1980. She is Deputy CEO at the Royal Australian and New Zealand College of Obstetricians and Gynaecologists and edits the college magazine *O&G*, which has a regular section devoted to the history of the specialty.

ANN WESTMORE is a former science journalist and writer who is currently working on a PhD on the history of lithium and the treatment of mood disorders under Dr John Cade in Melbourne.
